Todd Dixon, RTAC Chair welcomed those in attendance and confirmed that a quorum was present.

### **Updates:**

# **Georgia Office of EMS and Trauma Update:**

Kelly Joiner, Deputy Director for the Office of EMS and Trauma, reminded those present that online training is now available in the TRAIN system. EMS personnel can access TRAIN from the Office of EMS and Trauma website. They will need to create and log in and set up their profiles once in the system. EMS agencies and partners can upload content to TRAIN.

Kelly also briefly reviewed the process of credentialing providers for Post-Licensure Skills (PLS) and shared that the Education Advisory Subcommittee has a new draft policy posted on the Office of EMS website for review and public comment.

Other items of note:

The provision of provisional licenses and reinstatement licenses will end with the expiration of the Public Health Emergency.

The Office of EMS is monitoring a number of overdose clusters related to counterfeit opioids (pills).

# **Georgia Trauma Commission Update:**

Liz Atkins, Executive Director of the Georgia Trauma Commission provided a brief Trauma Commission update. She reported that new legislation will change how the Commission and other entities are awarded dedicated funds. Basically, the legislation will create a trust for Super Speeder and other designated funds.

### **Performance Improvement**

Lynn Grant indicated that the PI Subcommittee is still experiencing challenges regarding the meeting schedule due to the ongoing issues created by COVID 19 as many of the committee members are responsible food additional COVID response duties. Instead, they feel it is best to resume a needs-based meeting schedule, determined by the submission of cases identified performance improvement needs of the RTAC. They hope to resume a more regular meeting schedule soon.

She reminded those in attendance that anyone can submit a case for review. Basically, the discussions are centered around what can be learned from the case. Committee members signed confidentiality agreements and all cases are blinded so that the location, names of the patients, responders, agencies, and facilities are redacted. She also stated that it is as important that successes are reviewed as much as concerns. The RTAC PI Subcommittee works with the Education Committee to develop training offerings.

Prehospital lactate study – Lynn indicated that she hopes that the prehospital lactate study will be able to get underway in the near future. Houston Healthcare EMS has agreed to assist with that study. Understandably, the participating incidents don't have the bandwidth to initiate the program at the moment.

To date, the PI subcommittee has reviewed 36 cases. The RTAC PI Subcommittee will continue to review referred cases, tourniquet utilizations by law enforcement, multiple casualty incidents, pediatric imaging, and use of Power Share.

### **Education:**

# **Injury Prevention:**

Kristal Smith reported that the Injury Prevention Subcommittee remains focused on preventative efforts despite the challenges of COVID 19. She reviewed some of the regional IP initiatives including The Drive Through for Health and Safety, Safe@Home, RideSafe Central Georgia, and Georgia Stay S.A.F.E. They are looking forward to a coming Fall Prevention initiative, Bingocize. The program is a collaboration between the Middle Georgia Regional Commission, AAAs statewide, and the Georgia Trauma System.

The RTAC will be partnering with Fairview Park Hospital, the South-Central Health District, and EMS for Children for another Drive Thru for Health and Safety event in Laurens County. We hosted our first Drive Thru for Health and Safety event at Heartland EMS. The team at Heartland EMS and the Bleckley County community were phenomenal. Over 400 children were provided with school supplies, bicycle helmets, cloth masks, and other health and safety resources.

The IP Subcommittee also participated in a strategic planning session on March 31st and prepared a proposal for FY 22 RTAC Support Funds.

   Includes small monthly stipend for social media content manager/program assistant. Content directed by RTAC Executive Committee, Program Coordinator, Performance Improvement Committee, Injury Prevention Committee, and/or Education Committee.
- Regional Injury Prevention no change, objectives, and expenditures to be directed by the Injury Prevention Subcommittee in accordance with the Regional Trauma Plan.
- Regional Trauma Education no change, objectives that objectives and expenditures be directed jointly by the RTAC PI Subcommittee and Regional Education Committee in accordance with the Regional Trauma Plan.
- RTAC Related Travel no change, anticipated travel restrictions, and more web-based meetings.

Any funds requiring reallocation must be reallocated to support RTAC education and/or injury prevention initiatives.
